

President Dutremble requested a motion to move the consent agenda. <u>Comm. Fournier made the</u> <u>motion</u> which was <u>seconded</u> by Comm. Gorden, and the motion to approve the consent agenda <u>passed</u> with no opposition.

3. Officer Reports:

Comm. Fournier, Chair of the Budget and Finance Committee reported that the CD which the Board of Directors voted to acquire had been purchased.

3.3. President Report, Richard Dutremble

Comm. Dutremble reported that he was now working for the City of Biddeford on a part-time basis.

4. Standing Committee Reports:

4.1. NACo Update: Peter Baldacci & Sharyn Pohlman

Comm. Pohlman reported there was a threat to overturn the ARPA rules which was overturned. Currently, the money must be obligated by the end of December 2024, then the contracted work needs to be completed by the end of 2026. Comm. Baldacci said NACo is supporting a long-term reauthorization of the Farm Bill to help counties provide critical investments in our nation's most underserved communities. NACo supports rural economic development initiatives, education and nutrition programs such as SNAP (Supplemental Nutrition Assistance Program). NACo will have its Annual Conference in Tampa, Florida from July 12th to July 15th.

4.2. Convention Planning Committee: Lauren Haven

Admin. Lauren Haven reported that the Convention Planning Committee had held a hybrid meeting on June 7th. The next meeting will be at Sugarloaf in July for a food tasting and walk through of the event space. The planning was ongoing for educational sessions, fun activities, food and entertainment. She invited interested county representatives to join the committee. Registration was expected to open in July for the September conference.

Lobbyist Brody Haverly-Johndro announced he was leaving Verrill Dana on July 1st for a position in Washington DC. Although he enjoyed working with us, he was looking forward to new challenges.

Lobbyist Jim Cohen talked about educating the legislators about county issues. He recommended scheduling a tour of the jail with legislators. It is important for new legislative committee members to understand our position on jail finances. Secondly, he said we need to work with the administration. MCCA and/or MSA needs to have a conversation with the Governor's political advisor, Mary Anne Turowski, about jail budget shortfalls. Admin. Scott Ferguson, who is gathering data, has asked for the county jail budget numbers by July 1st to demonstrate the need for additional funding. Comm. Gorden said we need to make sure the CRAS reports have been submitted to the Department of Corrections through May.

Mr. Cohen said the Legislature adjourned with hundreds of bills left hanging. Unless the Legislature goes back into session, these bills will probably die via the pocket veto mechanism in which the bills will be left unsigned until it is too late for it to be dealt with during the legislative session. Admin. Tim Curtis said it makes sense to focus on Medically Assisted Treatment (MAT) as the Governor has shown an interest in funding it. Jim said one approach that would be in our best interest would be some annual percentage. That way, as costs increase, the amount distributed to counties would also increase. It would be similar to school funding; 20% or some other relative number should be provided by the state on an annual basis. We can't argue that MAT is an unfunded mandate because, although the amount wasn't sufficient, four million dollars had been allocated in the supplemental budget for MAT. Admin. Jeff Chute said he was a jail administrator for twelve years. In his opinion, MAT is a driver but there are other needs. We don't want money to be set aside only for MAT. The problem is that the pool of money is limited, and everyone is fighting over the same dollars. Comm. Baldacci said Penobscot County had to use ARPA money to support their jail. Jim said if we want to push the argument that the jails need more money due to unfunded mandates, we might consider going to court to determine exactly what is the definition of an unfunded mandate. If we want to elevate the issue it would need to be a lawsuit which we might lose, but it would be the only way to get the question answered.

Comm. Gorden inquired about the policy language that extended the holding time from six months to nine months in county jails. Mr. Cohen said he could look into that for us. Comm. Fournier asked if Mr. Cohen could put together a document for all the counties summarizing our priorities for the next legislative session. Comm. Gorden said we should also write something with general information about county commissioners and what do they do. The group talked about contacting candidates prior to elections. Lauren said she could get a list of candidates in each county.

Jim requested that Comm. Gorden schedule a Legislative Policy Committee meeting. After some discussion, the date was set for Monday, June 24th at 11:00 am via Zoom.
